## CRB<sup>®</sup> ANNOUNCEMENT FOLLOWING CONSULTATION ON REFINITIV/CORECOMMODITY CRB INDICES DISSEMINATION

Refinitiv Benchmarks Services (UK) Limited, as the benchmarks administrator for the Refinitiv/CoreCommodity CRB<sup>®</sup> Index (along with sub-indices) previously requested wider [market feedback](#) on the Index dissemination frequency change and found no objection on proposed changes.

As a result, Refinitiv Benchmarks Services (UK) Limited, after consultation with the Refinitiv/CoreCommodity CRB Oversight Committee, has decided to apply all Refinitiv/CoreCommodity CRB<sup>®</sup> Excess and Total Return Indices, including sub-indices and variants, be **disseminated only at the close of each business day** on which US futures market NYMEX is open for business **effective from 1<sup>st</sup> September 2021**.

Refinitiv Benchmarks Services (UK) Limited is communicating with applicable regulators with respect to these changes and is applying its operational policies to protect benchmark reliability.
