### Section 1 Introduction

### 1. Introduction

#### 1.1 FTSE US Government Bond Index

- 1.1.1 The FTSE US Government Bond Index measures the performance of fixed-rate US government bonds.
- 1.1.2 The FTSE US Government Bond Index does not take account of ESG factors in its design.

#### 1.2 FTSE Russell

FTSE Russell is a trading name of FTSE International Limited, Frank Russell Company, FTSE Global Debt Capital Markets Limited (and its subsidiaries FTSE Global Debt Capital Markets Inc. and FTSE Fixed Income Europe Limited), FTSE Fixed Income LLC, FTSE (Beijing) Consulting Limited, Refinitiv Benchmark Services (UK) Limited, Refinitiv Limited and Beyond Ratings.

# Section 2 Management responsibilities

### Management responsibilities

#### 2.1 FTSE Fixed Income LLC (FTSE)

- 2.1.1 FTSE is the benchmark administrator of the index series<sup>1</sup>.
- 2.1.2 FTSE is responsible for the daily calculation, production and operation of the index series, and will:
  - maintain records of the index weightings of all constituents;
  - make changes to the constituents and their weightings in accordance with the ground rules;
  - carry out the periodic index reviews of the index series and apply the changes resulting from the reviews
    as required by the ground rules; and
  - disseminate the indices.

#### 2.2 Amendments to these ground rules

- 2.2.1 These ground rules shall be subject to regular review (at least once a year) by FTSE Russell to ensure that they best reflect the aim of the index series. Any proposals for significant amendments to these ground rules will be subject to consultation with FTSE Russell advisory committees and other stakeholders if appropriate. The feedback from these consultations will be considered by the FTSE Russell Index Governance Board before approval is granted.
- 2.2.2 As provided for in the Statement of Principles for FTSE Russell Fixed Income Indices, where FTSE Russell determines that the ground rules are silent or do not specifically and unambiguously apply to the subject matter of any decision, any decision shall be based as far as practical on the Statement of Principles. After making any such determination, FTSE Russell shall advise the market of its decision at the earliest opportunity. Any such treatment will not be considered as an exception or change to the ground rules, or to set a precedent for future action, but FTSE Russell will consider whether the ground rules should subsequently be updated to provide greater clarity.

### 3. FTSE Russell index policies

#### 3.1 Statement of Principles for FTSE Fixed Income Indices (the Statement of Principles)

Indices need to keep abreast of changing markets and the ground rules cannot anticipate every eventuality. Where the ground rules do not fully cover a specific event or development, FTSE Russell will determine the appropriate treatment by reference to the Statement of Principles for FTSE Fixed Income Indices, which summarises the ethos underlying FTSE Russell's approach to index construction. The Statement of Principles is reviewed annually and any changes proposed by FTSE Russell are presented to the FTSE Russell Index advisory board for discussion before approval by the FTSE Russell Index Governance Board.

#### 3.6 FTSE Russell Governance Framework

3.6.1 To oversee its indices, FTSE Russell employs a governance framework that encompasses product, service and technology governance. ### 4. Composition and design criteria

The FTSE US Government Bond Index is based on of the FTSE World Government Bond Index (WGBI). For more information on the WGBI, please see the <u>FTSE Fixed Income Index Guide</u>.

Minimum issue size	USD 5 billion public amount outstanding (excludes Federal Reserve holdings).		
Composition	Sovereign debt denominated in the domestic currency including callable bonds. Variable-rate, floating rate, fixed-to-floating rate, index-linked, retail directed, bills, stripped zero coupon, convertibles, savings, private placements and dual-currency bonds are excluded.		
Weighting	Market capitalisation		
Rebalancing	Once a month at the end of the month.		
Reinvestment of cash flows	Intra-month cash flows from interest and principal payments are not reinvested as part of monthly index total return calculations <sup>5</sup> .		
Pricing	Refinitiv bid-side 4pm (New York)		
Calculation frequency	Daily		
Settlement date	Monthly: settlement is on the last calendar day of the month. Daily: same-day settlement except if the last business day of the month is not the last calendar day of the month; then, settlement is on the last calendar day of the month.

#### 4.1 Holiday calendar

4.1.1 The index is calculated Monday through Friday except Christmas Day (observed) and New Year's Day (observed). Each local market will observe its own holiday calendar. If a local market is on holiday, the closing prices used for that day will be the closing prices from the previous day.

#### 4.2 Index quality

4.2.1 An index quality is assigned to each index bond as of profile fixing. The quality is first mapped to the Standard & Poor's Financial Services LLC (S&P) rating. If a bond is not rated by S&P but it is rated by Moody's Investors Service, Inc (Moody's), the S&P equivalent of the Moody's rating is assigned to the index quality. If a bond is rated by neither S&P nor Moody's, the bond is not assigned an index quality. If a bond is rated by one rating agency and high yield by the other, the S&P equivalent of the investment-grade rating is assigned to the index quality. These ratings remain unchanged for the entire performance month.

#### 4.3 Exchange rates

4.3.1 The closing Refinitiv spot rates and the Refinitiv forward rates, provided by Refinitiv, are used. Refinitiv takes several snapshots at regular intervals centred on the fixing time of 16:00 London time and selects the median rate for each currency. All rates are mid-market quotations and appear on Refinitiv (see WMRSPOT01).

#### 4.4 Return computation

4.4.1 Total returns are computed on the assumption that each security is purchased at the beginning of the period and sold at the end of the period. An issue's total rate of return is the percentage change in its total value over the measurement period (see figure one). The components of total return are price change, principal payments, coupon payments and accrued interest. The total returns use each individual security's beginning-of-period market value.

#### Figure one: total rate of return calculation methodology

Beginning-of-period value	-	(Beginning price + Beginning accrued) x Beginning par amount outstanding
End-of-period value	-	[(Ending price + Ending accrued) x (Beginning par amount outstanding - Principal payments)] + Coupon payments + Principal payments
Total rate of return (%)	-	[(End-of-period value/Beginning-of-period value) - 1] x 100

A note on precision: returns are computed to at least six decimal places but reported to a maximum of four. In addition, owing to rounding inaccuracies inherent in computer floating-point arithmetic, the last digit in any reported value may sometimes be off by one from its true value.

This equation holds true only if the spot rates are quoted as base currency per unit of foreign currency.
